Undergraduate Students

- May receive a maximum of \$16,000 towards their undergraduate studies
- The current maximum amount per academic year is \$3,772*

Graduate students

- May receive a maximum of \$8,000 towards graduate studies
- The current maximum amount per academic year is \$3,772*

TEACH Grant amounts will be prorated based on enrollment as follows:

- Full-time (12+ Credits): \$3,772* per year divided by the number of semesters enrolled
- Three-quarter (9-11 Credits): \$2,829* per year divided by the number of semesters enrolled
- Half-time (6-8 Credits): \$1,886* per year divided by the number of semesters enrolled
- Less than half-time (5 or less): \$943* per year divided by the number of semesters enrolled

**As required by the Budget Control Act of 2011 (the sequester law), any TEACH Grant where the first disbursement is on or after October 1, 2020 requires a reduction of 5.7% from the award amount for which the student would otherwise have been eligible.*

TEACH GRANT AGREEMENT:

The TEACH Grant is only a Grant as long as you fulfill the service requirements. By initialing each of the following statements, you acknowledge that you understand the service requirements and the significance of not meeting these requirements.

___ I am required to teach full-time in a low-income school

___ I am required to teach in a high-need field

___ I am required to teach full-time for at least four school years within eight years after I complete or cease to enroll in the program for which I received a Teach Grant

___ If I do NOT fulfill these service requirements, the Teach Grant will be converted into a Federal Direct Unsubsidized Stafford Loan. I will have to repay this loan in full, with interest accruing from the date of each TEACH Grant disbursement
